26/111	Public Forum. Debbie Shultze addresses the meeting to discuss the application for 41 Summerfields, 2026/1456/LDP . As this had already be approved by WNC, the resident was referred to WNC and the local WNC councillors for any further information. Concerned was expressed by the resident that no notice of this planning permission had been received by those impacted. Clerk to follow up to the Planning Dept at WNC on a general issue of what the procedures are for informing impacted residents for any planning applications. Stephen Brooks, a resident of Merry Hill expressed concern at the excessive road noise from the main dual carriageway leading off the roundabout (A5123 Danes Camp Way) and asked if anything could be done about it (trees were not an option due to the proximity of housing). The council agreed to pass the comments onto WNC Highways to see if any acoustic fencing or other sound deadening measures could be provided in that area.
